USF
Sarasota-Manatee

- Eligible students must be a junior or senior
- Classes may be on the PHS Campus, or you can take 2 courses at USF Sarasota campus
- You must provide your own transportation to courses on the USF campus
- Qualifying GPA - 3.5 weighted GPA
- Qualifying Test Scores

- Eligible students must be a junior or senior
- Classes are on SCF Campus, you must provide your own transportation to SCF
- Full time or Part Time options
- Qualifying GPA 3.0

Two Types of Early College Programs

Dual Enrollment

- Allows eligible high school students to earn both high school and college credit
- Courses are potentially offered at PHS and SCF or USF campuses
- 11th grade students are permitted to take up to 2 courses per semester at the College campus in addition to a partial class schedule at PHS
- Part Time DE students must have at least 3.50 credits per semester
- College courses cannot interfere with PHS schedule
- A student may enroll in a combination of both DE and AICE courses

EARLY ADMISSIONS

- Allows eligible high school students to earn both high school and college credit
- A form of Dual Enrollment for 12th grade students only
- Courses are taken solely at the SCF campus...you do not attend classes at PHS
- Students must enroll in 12 – 15 credit hours per semester (typically between 4 -5 courses)
- Students create their own schedules
- EA students may still participate in PHS sports, extracurricular activities, and events



Comparison of Dual Enrollment and AICE

How College Credit is Awarded

Dual Enrollment

- Student completes the DE course.
- If a student earns a C or higher, a college credit is earned and will be accepted by most other institutions.
- A grade of D or F does not earn college credit
- Typically 3 credit hours

AICE

- Students take an AICE exam in May/June and must receive a passing score to earn college credit
- Universities award college credit based on the articulation agreement

How GPA is Recorded/Course Length

Dual Enrollment

- The grade earned in the DE class is applied to the high school GPA and also becomes part of the student's post-secondary transcript
- One additional quality point is added to the 4.0 scale (weighted GPA)
- DE courses will be offered as they are at SCF or USF Manatee— one semester per course

AICE

- The grade earned in an AICE course is only applied to the high school GPA
- One additional quality point is added to the 4.0 scale (weighted GPA)
- AICE courses are yearlong classes

Benefits and Risks

Dual Enrollment

- + If a student is successful in the course, the college credit is granted
- Course credit is recognized by the public universities in Florida but not necessarily by all universities nationwide
- If a student does poorly in the course, the grade follows the student to college and could negatively impact a student's chances of being admitted

AICE

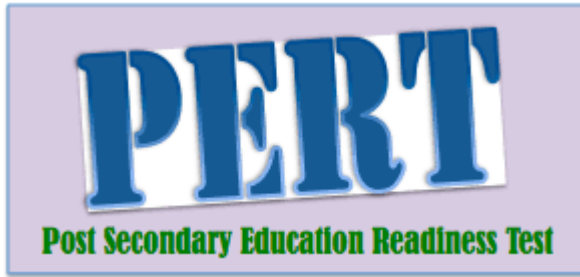
- + The AICE program is nationally recognized as a college-level curriculum
- + A poor grade in an AICE course only affects a student's high school record
- + All AICE courses are offered on PHS campus
- Each university decides how to grant college credit depending on a student's AICE score

- You must register BY February 8, 2023 either by scanning the QR Code or with Ms. Kayla in Student Services.



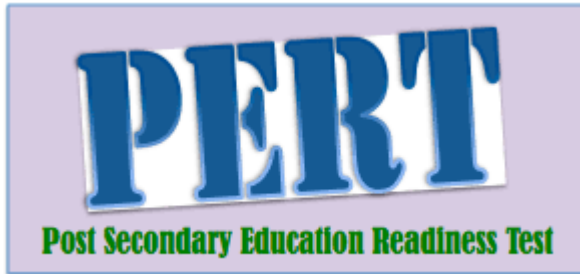
- SAT Test date is March 11
