

Lakewood Ranch High School School Advisory Committee Meeting Agenda Tuesday, March 30, 2021 6:00 pm ~ Microsoft Teams

I. Welcome and Approval of Minutes- Ms. Marni Mount called for the meeting to start at approximately 6:11 pm. Ms. Bieber welcomed everyone to the meeting.

- II. Old Business- Ms. Lowen introduced the motion to approve the minutes from the November meeting. The motion is seconded by Ms. Kristina Enselberg. A vote is called to approve the November minutes. The motion passes and the November minutes are approved. Ms. Lowen introduces the motion to approve the January minutes. The motion is seconded. Ms. Nadine moves to amend the minutes by striking the phrase Dominik and inserting the word "Nadine" in the minutes. The amendment is seconded. A vote is called to amend the minutes and the amendment passes. Ms. Bieber motions to approve the January minutes as amended. The motion to approve the amended January minutes is seconded by Kristina Engelsberg. A vote is called and the motion to approve the minutes is passed unanimously.
- III. New Business
 - a. 2021-2022 Class Registration- Ms. Lowen
 - i. The guidance counselors have begun the registration process for the upcoming school year. Students and parents have been contacted and a student curriculum can be found online through the school's website. Administrators have begun processing requests for students' schedules. About 2200 students are expected for next year. The school district is currently concerned that enrollment may drop next year as a result of the COVID-19 pandemic. The school has eliminated hybrid learning modality this semester. The students were given the choice of on-campus learning or e-

 learning. There are currently 1,776 on campus learners and 632 e-learning students. This semester the school has also brought back the long time Mini-Mustangs program. There are eight pre-k students on campus who will assist students in early childhood education students to earn their certification. The school continues to adhere to all recommended safety guidelines in relation to the pandemic. There are a few cases now and then, but the school remains relatively safe and enforces safe practices. ii. Ms. Potter states that she missed the printed curriculum guides. She also voiced concerns about a lack of information for registration for e-learners. Ms. Bieber explains the curriculum guides costed too much money to be printed. iii. Nadine says she is thankful to Ms. Williams for calling her after office hours to help her with her child's schooling and registration. Ms. Lowen explains that resources have been given to students who are brick and mortar students. b. Testing- Ms. Lowen and Ms Bieber i. In the month of March the school began with senior and dual enrollment PERT testing. Over 90% of seniors took SAT

 - Flag football coach Mr. Weaver received the regional positive coaching c. alliance Tampa Bay double gold award. He is now in the running to receive the national award.  - d. The JROTC orienteering team earned the school's first overall state championship this past Saturday, despite having lost 25% of the team due to COVID contact tracing.
